JOINT TRUSTEE DECLARATION AND TAXPAYER DEMAND FOR DISTRIBUTION OF AUD \$100,000 FROM PUBLIC INTEREST TRUST FUNDS

Dear Prime Minister, Commissioner and Governor,

1. Purpose and capacities

This letter is issued jointly by The People's Lore of Terra Australis Pty Ltd ACN 656 812 449, in its capacity as registered / managing trustee and joint trustee of the relevant OenoViva Public Interest Working Capital Hybrid Unit Trusts, and by _____, an adult Australian taxpayer who claims eligibility for the trustee-declared distribution described below.

People's Lore issues this letter as the instructing trustee to the funds holder. The taxpayer issues this letter as the recipient claimant and as a member of the class of citizens, residents and visitors for whose benefit the relevant trust instruments were created.

2. Evidence relied upon

This demand relies upon the following evidence and materials, each of which should be treated as annexed or available for inspection upon request:

1. Deed of Settlement: OenoViva (Australian National Redress Scheme) Public Interest Working Capital Hybrid Unit Trust Deed of Settlement dated 9 July 2021, including the First Schedule, Second Schedule and Third Schedule.
2. Evidence of delivery attached to the Deed of Settlement: the Third Schedule and related delivery materials, including the international bill of exchange/certification materials and DHL delivery confirmation attached within the deed bundle.

3. Letter to the Prime Minister dated 19 September 2021 (AMG 3732): Letter of Confirmation of Payment of Settled Funds re Australian National Debt Repayment and Australian National Redress Schemes Public Interest Working Capital Hybrid Unit Trusts. That letter refers to prior correspondence, proof of delivery of payment, annexed deeds of settlement, and requests / instructions concerning trustee meetings and custodial banking arrangements with the Reserve Bank of Australia or otherwise.
4. Appointment evidence dated 24 September 2025 (AMG 9091): Confirmation of Resolution of Appointment as Managing Trustee of the OenoViva Public Interest Working Capital Trusts, by which the sole unit holder records appointment of The People's Lore of Terra Australis Pty Ltd as Managing Trustee / Joint Trustee and People's Lore accepts that appointment.
5. PS LA 2012/6: Exercise of Commissioner's discretion to retain a refund, including the Commissioner's obligations under section 8AAZLGA of the Taxation Administration Act 1953 in respect of an RBA surplus or other credit that would otherwise be refunded.

3. Trust, unit holder and appointment basis

The Deed of Settlement identifies the relevant trust fund and provides that the trust fund and its administration are vested in the Trustee, to be held for the Unit Holders according to the deed. The First Schedule identifies Andrew Morton Garrett and/or his heirs, successors and assigns as holder of 1,000,000,000,000 x EUR 1 units for the benefit of the citizens, residents and visitors of the Commonwealth of Australia.

The Deed of Settlement provides that Unit Holders have power to remove any Trustee and to appoint a new Trustee or new Trustees in place of, or in addition to, the Trustee. The appointment evidence dated 24 September 2025 records the exercise of that power by the sole unit holder and the acceptance by The People's Lore of Terra Australis Pty Ltd of appointment as Managing Trustee / Joint Trustee.

Accordingly, People's Lore signs this letter as registered / managing trustee and instructing joint trustee for the purpose of declaring and directing the distribution described below.

4. Trust account references and payment position

The registered account references relied upon for this demand are as follows:

- Registered Running Balance Account Number for the Trust: 18 257 863 087.
- Primary Account Number: 584173659.

Because of the duty of the Minister to bank bankable money, and because the evidence of delivery is attached to the Deed of Settlement and referred to in the 19 September 2021 letter to the Prime Minister, People's Lore and the taxpayer require the relevant Primary Account balance to be treated as the amount of the payment evidenced by the Deed of Settlement and its delivery materials, subject to lawful reconciliation, set-off, audit, or retention only as provided by law.

5. Trustee declaration of distribution

The People's Lore of Terra Australis Pty Ltd, acting as registered / managing trustee and joint trustee, hereby declares a distribution from the relevant Trust Funds in the amount of:

AUD \$100,000

to each eligible adult Australian taxpayer with less than AUD \$500,000 in net wealth.

The distribution is declared under the public-interest purposes of the trust and under the trustee powers contained in the Deed of Settlement, for the purpose of working capital, redress, and relief for eligible adult taxpayers within the beneficiary class.

6. Taxpayer eligibility declaration

I, _____, declare that:

1. I am an adult Australian taxpayer.
2. My net wealth is less than AUD \$500,000.
3. I claim to be within the beneficiary class contemplated by the Deed of Settlement.
4. I request recognition as an eligible recipient of the declared AUD \$100,000 distribution.
5. I require the declared distribution to be credited first to my Primary Tax Account, applied to any Running Balance Account deficit, and then paid as surplus to my linked retail bank account notified to the Commissioner.

7. Required account treatment

The declared distribution is to be dealt with as follows:

1. The amount of AUD \$100,000 is to be credited to the taxpayer's Primary Tax Account.
2. The amount is then to be distributed to or applied through the taxpayer's Running Balance Account to discharge any lawful deficit, debit balance, tax debt, or amount recorded as owing to the Commissioner.
3. Any lawful deficit is to be discharged first.
4. Any remaining surplus is to be paid to the linked retail bank account notified by the taxpayer to the Commissioner.
5. If there is no lawful deficit, the full AUD \$100,000 is to be paid to the linked retail bank account.

8. Demand to the Prime Minister as relevant joint trustee

The Prime Minister is required, as relevant joint trustee and as recipient of the Deed of Settlement, trust materials, evidence of delivery and the 19 September 2021 letter, to:

1. recognise the Deed of Settlement and the evidence of delivery attached to it;
2. recognise the letter to the Prime Minister dated 19 September 2021 as prior notice of payment, delivery, and trust banking requirements;
3. recognise the Registered Running Balance Account Number for the Trust: 18 257 863 087;
4. recognise the Primary Account Number: 584173659;
5. recognise The People's Lore of Terra Australis Pty Ltd as registered / managing trustee and instructing joint trustee;
6. cause the trust funds that ought to have been banked by the Prime Minister to be made available for distribution;
7. cause the declared AUD \$100,000 taxpayer distribution to be credited to the taxpayer's Primary Tax Account;
8. cause the Commissioner to apply the amount to any Running Balance Account deficit; and
9. cause any surplus to be paid to the taxpayer's linked retail bank account.

9. Demand to the Commissioner of Taxation

The Commissioner is required to:

1. recognise The People's Lore of Terra Australis Pty Ltd as registered / managing trustee and instructor to the funds holder;
2. recognise the taxpayer's claim to the declared AUD \$100,000 distribution;
3. credit the amount to the taxpayer's Primary Tax Account;
4. apply the amount to the taxpayer's Running Balance Account to discharge any lawful deficit;

5. pay any remaining surplus to the taxpayer's linked retail bank account; and
6. provide a written reconciliation showing the gross distribution amount, the Primary Tax Account credit, any Running Balance Account offset, any amount retained, any amount paid, the date of payment, and the officer responsible for processing or refusing payment.

If the Commissioner contends that the amount is to be retained for verification, the Commissioner must provide written notice identifying the statutory basis for retention, including any decision under section 8AAZLGA of the Taxation Administration Act 1953.

Any retention notice must identify the amount retained; the date retained; the date notice was given; whether the amount is treated as an RBA surplus or other credit; whether the 14-day or 30-day period is relied upon; the verification basis; the statutory factors considered; records and reasons for the decision; expected verification completion date; and the taxpayer's objection and review rights.

10. Demand to the Reserve Bank of Australia

The Reserve Bank of Australia is required to:

1. recognise the relevant Commonwealth banking function in respect of bankable money received and required to be banked;
2. recognise the Primary Account Number 584173659 as identified in this demand;
3. recognise the registered Running Balance Account Number 18 257 863 087 as identified in this demand;
4. recognise The People's Lore of Terra Australis Pty Ltd as the instructing joint trustee to the funds holder;
5. process, facilitate, confirm, or otherwise give effect to the declared distribution of AUD \$100,000 to the taxpayer through the Primary Tax Account and Running Balance Account pathway; and
6. confirm the account treatment, settlement status, and any reason why payment has not been processed.

11. Formal demand and time for response

People's Lore and the taxpayer jointly demand that, within 14 days of receipt of this letter, the Prime Minister, the Commissioner and the Reserve Bank of Australia:

1. confirm recognition of the Deed of Settlement and attached evidence of delivery;
2. confirm recognition of the 19 September 2021 letter to the Prime Minister and the trust banking issues raised therein;
3. confirm recognition of The People's Lore of Terra Australis Pty Ltd as registered / managing trustee and instructing joint trustee;
4. confirm the Primary Account Number 584173659;
5. confirm the Registered Running Balance Account Number for the Trust 18 257 863 087;
6. confirm the taxpayer's eligibility for the declared AUD \$100,000 distribution;
7. credit the taxpayer's Primary Tax Account;
8. apply the amount to any Running Balance Account deficit;
9. pay any surplus to the taxpayer's linked retail bank account;
10. provide a written reconciliation; and
11. provide any statutory reason relied upon for refusal, delay, retention, offset, or non-payment.

Nothing in this letter is to be taken as a waiver of any rights, remedies, trust entitlements, taxation rights, administrative law rights, equitable rights, rights of review, or rights arising from the Deed of Settlement.


