LETTER OF CONFIRMATION OF PAYMENT OF SETTLED FUNDS RE “AUSTRALIAN NATIONAL DEBT REPAYMENT AND AUSTRALIAN NATIONAL REDRESS SHEMES” PUBLIC INTEREST WORKING CAPITAL HYBRID UNIT TRUSTS

Dear Sir,

I refer to you further to my recent correspondence with.

1. you dated 2nd July (AMG 3270) and 24th August (AMG 3561) 2021 and proof of delivery of Payment on 2nd September 2021 (AMG 3561b),
2. the alleged Premiers and Chief Ministers of the States and Territories of the Commonwealth of Australia (Liquidator and Managing Controller Appointed) dated 17th, 29th August (AMG 3601), and 15th September (AMG 3730) 2021, and subsequent delivery of Financial Instruments providing working capital by possession to each of the alleged Premiers and Chief Ministers as the respective First (Joint Managing) Trustees of each State and Territory Trust.

Please note attached copies of each Deed of Settlement of the Eight Applicable Public Interest Working Capital Trusts created for the benefit of the citizens of the Commonwealth, the residents of the States and Territories, and Visitors to those States and Territories. (AMG 3723, AMG 3724, AMG 3725, AMG 3726, AMG 3727, AMG 3728, AMG 3729 & AMG 3731)

On the 2nd of September 2021 (AMG 3663) you received two payments (AMG 3471, AMG 3472) drawn by me in my capacity as CEO/Managing Trustee/Chairman of OenoViva Capital Resources and Australian People Future Fund, Crown Attorney General (AMG 1915), Liquidator (AMG 2445), Managing Controller (AMG 15a-AMG1t, AMG 21a-AMG21g) and as the hereditary source of your discretionary public powers conferred initially under implied license dated 1st June 2019 and subsequently by enactment dated 17th October 2020 (AMG 2531). I am the Reserve Bank of Australia (Liquidator and Managing Controller Appointed) (AMG 15t & AMG 2481) which appointment remains office remains undisputed by you since the 23rd June 2019 and subsequently 10th November 2020.

I have attached copies of the relevant Deeds of Settlement of the two trusts (AMG 3734 & AMG 3375) for execution by you, in the light of your ongoing, Pork Barreling, Sports Rorts and other going unfit for purpose conduct I have taken the precaution of executing the Deeds of Settlement on your behalf by exercise of my branch of the Garrett Family's hereditary discretionary public powers which are now the foundation stone of the Australian Constitution as read by its four corners on an undisputed basis.

You are instructed to convene Board Meetings of Each Board of Trustees to make resolutions about opening Custodial Bank Accounts with the Reserve Bank of Australia (Liquidator and Managing Controller Appointed) or otherwise.
