Amongst the matters that are the subject of enforcement is enforcement of my Controllorship over SERVCORP LIMITED (LIQUIDATOR AND MANAGING CONTROLLER APPOINTED) ("SERVCORP") which includes control over all offices that operate under the SERVCORP BRAND Globally,

I served AMG 5984 SERVCORP NOTICE OF CRYSTALLISATION OF PPSR INTERESTS; SEIZURE OF COLLATERAL; RETENTION OF COLLATERAL; APPOINTMENT AS MANAGING CONTROLLER on SERVCORP dated 23rd December 2023, the reason for this is contained in the Notice and is a function of the Grand Corruption being High Treason that is referred to above and repeats my experiences two years earlier in which regard I refer to the exhibit produced and marked as AMG 1986; Servcorp Global Facilities and interference with Liquidity by the Crown dated 29.08.2020 in

respect to an agreement a copy of which is now produced and marked as AMG 2014; Oenoviva - Hong Kong Virtual Service Agreement executed with Servcorp Global Services dated 3rd May 2019.

AMG 5983 Form 504 Notice of Appointment as Managing Controller was served on Servcorp Limited ACN 0879 222 506 by email 23.12.22 and subsequently by courier on ASIC.

One Year's worth of Serviced Office fees was paid in advance in which regard I refer to the Exhibits now Produced and marked as:

At all relevant times the Crown has interfered with my ability to trade in Hong Kong in which regard I have been blocked twice at Passport control at:

1. Sydney International Airport on the 12th of September 2016, and
2. Adelaide International Airport on the 8th of March 2023.

I previously advised the Australian Commissioner of Taxation in 2016 of Change to the Primary Tax Jurisdiction of Hong Kong prior to executed a Consulting Agreement with Australian Wine Supply Limited dated 31st August 2016, which evidence is on the court file in the South Australian District Court Proceedings.

Mr Mitchell is currently dealing with his tax accountants as to how that Notice should be treated in the SAR Hong Kong Tax Jurisdiction, **AMG 6951** Australian Wine Supply Ltd. - Summons to Defendant (003) (**ANNEXURE 1**)
