TAKE NOTICE that the Applicant applies for leave to apply for judicial review of the decision, act, omission or continuing failure identified below.

1. Decision, act or omission challenged

1. The decision communicated on the 20 April -8 May 2026 that the Applicant's Net Asset Assessment application under the New Capital Investment Entrant Scheme, Transaction Reference IHK0010JMCKT9T09, was invalid by reason of the absence of Certified Public Accountant (Practicing) fulfillment material.
2. The continuing failure or refusal of the Proposed Respondent and/or officers acting under his authority to determine according to law the Applicant's request for review and exceptional consideration, including but not limited to the review materials dated 21 April 2026, later addenda, AMG 9552c dated 6 May 2026, and the exceptional-case question thereby raised.
3. The failure to identify the actual decision-maker, the source of authority or delegation relied upon, the materials considered, and the reasons for refusing or declining to consider any lawful evidentiary pathway.
4. The failure to engage with the post-20 April 2026 correspondence sequence, being repeated responses to the Applicant's continuing attempts to invoke lawful process and the full extent of the powers conferred under the Scheme Rules and applicable law.

2. Relief sought

5. Leave to apply for judicial review.
6. An order of mandamus requiring the Proposed Respondent, or the proper officer acting under his lawful authority, to determine according to law the Applicant's request for review and exceptional consideration.
7. A declaration that, in determining the Applicant's request, the Proposed Respondent must lawfully consider the materials provided by the Applicant and the question whether the Scheme Rules permit, require, or may lawfully be clarified, amended or applied so as to allow an exceptional evidentiary pathway in the circumstances of the case.
8. A declaration that the proper decision-maker must consider whether rigid insistence on paragraph 4.2 of the Scheme Rules, in the exceptional circumstances advanced by the Applicant, would frustrate the purpose and objects of the Scheme.
9. An order of certiorari, if necessary, quashing any decision treating the Applicant's Net Asset Assessment application as invalid insofar as that decision was made without lawful consideration of the Applicant Materials or on the basis of an erroneous construction of the Scheme Rules.
10. An ancillary order or direction that the Proposed Respondent lodge with the Court and serve on the Applicant, within 7 days or such other period as the Court directs, a paginated bundle containing all data, materials and records before the decision-maker at the time of each alleged decision sought to be impugned, together with an accompanying schedule identifying each item, the date received, from whom received, by whom considered, and whether it formed part of the original decision record, any review record, or any subsequent referral record.
11. Alternatively, an order that the Proposed Respondent file evidence identifying the decision-maker, source of authority, documents before the decision-maker, documents provided by the Applicant but not considered, and the reasons why any such materials were not considered, together with a schedule of that material sufficient to enable the Court to determine whether the alleged decisions were made *intra vires* or *ultra vires*.

12. An order preserving the Applicant's New CIES application, so far as necessary, pending determination of the application or further order.
13. Costs on an indemnity / solicitor-client basis.
14. Such further or other relief as the Court considers just.

3. Grounds

15. **Failure to consider material evidence:** The Applicant provided substantial materials to DGIP / InvestHK / New CIES Office in support of the bona fide nature, value, custody, provenance, legal context and proposed Hong Kong regulatory treatment of the Net Assets relied upon, including couriered exhibits, review addenda, hyperlink schedules, Safe Harbour material, source-of-power submissions, economic-objective material, One World Bancorp materials, and the PWC / director-regularization materials from March 2025. The decision-maker has not demonstrated substantive engagement with those materials before treating, maintaining or allowing the application to be treated as invalid.
16. **Failure to exercise the conferred power in its full scope:** The Proposed Respondent, or an officer acting under his authority, was required to exercise the assessment and review functions lawfully, rationally and by reference to the material before him. A public officer cannot lawfully dispose of the matter by mechanical repetition of an ordinary evidentiary requirement where the Applicant squarely raised an exceptional legal question as to whether the ordinary mechanism is practically unavailable and whether the Scheme admits any lawful exceptional pathway.
17. **Error of law / misconstruction of the Scheme Rules:** The Proposed Respondent may have treated the CPA fulfillment-document requirement as conclusively excluding any exceptional mechanism, amendment, clarification or modified evidentiary pathway, without considering paragraph 1.1, Note (3), paragraph 1.15.2, paragraph 4.12 and paragraph 4.13 of the Scheme Rules or the Government-announced purpose of the Scheme.
18. **Fettering of discretion:** If any discretion, evaluative power, amendment power, clarification power or procedural flexibility was available, it was unlawful to refuse to consider the Applicant's request by rigid application of the ordinary CPA pathway without addressing the exceptional circumstances advanced. The Applicant relies in this regard on the established principle against unlawful fettering of discretion and the authority that policy may guide discretion but may not be applied blindly or rigidly.
19. **Frustration of Scheme purpose:** The Government announced on 19 December 2023 that the New CIES was introduced to attract new capital to Hong Kong, promote family offices and strengthen Hong Kong's asset and wealth-management, financial and related professional service sectors. The Applicant's case is that the object of the applicant and the object of the Scheme are materially aligned, and that the ordinary CPA pathway, sensible at conventional levels of investment, may at extraordinary scale frustrate the very purpose of the Scheme.
20. **Procedural unfairness / inadequate reasons:** The Applicant requested confirmation that the matter had been placed before DGIP or the proper officer, that the materials had been considered, that the exceptional legal question had been addressed, and that reasons be provided if the Scheme was said to admit no discretion or exceptional mechanism. The failure to identify the decision-maker, materials considered, source of authority and reasons prevents the Applicant and the Court from testing whether the assessment function was lawfully exercised.
21. **Need for the Proposed Respondent's materials to be before the Court:** The central issue is whether the decision-maker acted lawfully on the materials actually before him. The Applicant does not seek to replace the decisional record by swearing the entirety of his own materials into evidence. Rather, he seeks orders

compelling the Proposed Respondent to produce the full decisional record with an accompanying schedule, because those are the materials on which the legality of the alleged decisions must be tested.

22. **Public interest / liquidity control:** The Applicant says this case engages the public interest because the conduct of the decision-maker is said to have the practical effect of controlling the Applicant's liquidity in the Territory by preventing or delaying the lawful admission, validation, and deployment of the Net Assets proposed to be invested in Hong Kong. The Applicant says this is not merely a private dispute about paperwork but raises broader questions about the lawful exercise of public power under the Scheme, the proper scope of the powers conferred, and whether the objects of the Scheme are being frustrated in an exceptional case of proposed capital inflow.
23. **Surveillance / travel-interference evidence:** The Applicant further relies on the events of 12 September 2016 at Sydney International Airport and 8 March 2023 at Adelaide International Airport as part of the Australian-agency-side evidentiary matrix. The Applicant says those events, taken together with the earlier announcement of change in primary tax jurisdiction to Hong Kong on or about 18 May 2016, are capable of supporting, at minimum on the permissive standard of credible evidence or reasonable grounds to suspect, an inference that official interference affected the Applicant's practical ability to travel to Hong Kong and pursue the Hong Kong-side process directly.
24. **Further affidavit materials already served on the Hong Kong side:** The Applicant says this is not merely a fresh assertion. By AMG 9505 dated 30 March 2026, the Applicant expressly identified and served into the New CIES record the sealed affidavit of cross-claimant dated 27 March 2023 and Annexure 5 to that affidavit, and also relies on AMG 7230, sworn on 14 March 2023 immediately after the Adelaide Airport blocking, as near-contemporaneous affidavit evidence which also refers to the Applicant's termination of Legal Services instructions. The Applicant says those materials place the travel-interference issue squarely within the existing review record.
25. **Basic Law / national security setting:** The Applicant further says that those travel-interference and surveillance matters are relevant in the constitutional and statutory setting of Hong Kong, including the Basic Law, the National Security Law 2020 and related local ordinance, because they are said to bear upon the lawful conditions under which value may be relocated to and held within the HKSAR and upon whether external interference has affected the Applicant's practical ability to engage the Hong Kong process directly.
26. **Alleged sanctionable conduct of Price Waterhouse / PricewaterhouseCoopers on the permissive standard of proof:** The Applicant also relies on the Australian corporate, tax and regulatory record as disclosing credible evidence and at least reasonable grounds to suspect sanctionable conduct by Price Waterhouse / PricewaterhouseCoopers in connection with the historical corporate, trustee and accounting affairs of The Andrew Garrett Group Pty Ltd / The Wine Company Pty Ltd and related entities. That allegation is put as an evidentiary matter, not yet as a finally adjudicated finding, and is relied upon as part of the broader factual matrix that the proper decision-maker was required to confront when assessing the bona fides, provenance and historical governance of the assets and structures advanced by the Applicant.
27. **Historical ASIC record gap and Price Waterhouse role:** The Applicant relies on the exhibited ASIC material as proving that the public ASIC extract does not disclose historical records for the period 18 July 1983 to 19 November 1990 in relation to The Andrew Garrett Group Pty Ltd / The Wine Company Pty Ltd, while also recording Price Waterhouse as a previous auditor with cease date 20 June 1990 and start date shown as unknown. That proved record gap, together with the alleged role of Price Waterhouse in the relevant period, is relied upon as supporting the need for production, explanation and witness evidence from Australian agencies and professional actors.

28. **Suntory Share Sale Agreement dated 21 July 1995:** The Applicant purchase all shares previously registered as owned by Suntory Holdings specifically refers to pre 1990 events that the Applicant has sought the detail of without success by applications to courts and tribunals in Australia for production of the File produced by Finlaysons Lawyers in instructions from the Applicant to commence proceedings related to the indemnities contained in that agreement.
29. **Sanctionable conduct of the High Court of Australia: Failing to list for argument HCA-A67-2004:** Andrew Garrett Wine Resorts Pty Ltd and Anor v National Australia Bank and the failure to restore equity and real property under the contractual right between subject and the Crown arising under the right to an effective remedy.
30. **Further evidentiary context:** the Applicant also relies on AMG 8782 dated 30 March 2025 and AMG 8806 dated 13 April 2025 as evidence of a continuing attempt, following the Applicant's February 2025 approach to the Chief Executive of Hong Kong, to engage the proper public, revenue, executive and professional channels relevant to Hong Kong. Those communications were addressed or copied to, among others, Ms Yung Wai-Yan of the Inland Revenue Department, PricewaterhouseCoopers addressees Mohamed Kande and Kevin Burrowes, the Chief Executive of Hong Kong care of Mr Andy Chan Private Secretary, and in AMG 8806 the Australian Commissioner of Taxation and relevant delegates including Vincent Tavolaro of the Australian Government Solicitors Office. The Applicant relies on those communications as evidence that he was attempting in good faith to engage the relevant pathways and suitable professional support, and that the impugned decision-maker was required to consider that factual context when assessing whether an exceptional pathway, clarification or lawful accommodation required consideration.
31. **Money Laundering and Terrorism Financing:** The Applicant relies by analogy on s 29 of the *Public Interest Disclosure Act* 2013 (AU) as identifying categories of public-sector wrongdoing, disclosable conduct and public-interest disclosure. In Hong Kong law, there is no single equivalent Public Interest Disclosure Act. The closest functional equivalents are the Hong Kong statutory regimes for corruption, maladministration, criminal referral, money laundering, terrorist financing and public-administration accountability, including Cap. 201, Cap. 204, Cap. 397, Cap. 455, Cap. 575 and Cap. 615. The Applicant does not rely on those Hong Kong provisions as creating an identical Australian-style PID scheme, but as identifying the Hong Kong mechanisms through which disclosed material revealing corruption, maladministration, indictable offences, proceeds of crime, money laundering or terrorist financing may be referred, preserved, investigated or acted upon according to law.
32. **Further evidentiary context:** the Applicant also relies on Reserve Bank of Australia addressees and related correspondence, including an official electronic mail dated 3 January 2024 from an RBA representative and a later email dated 20 May 2025 from Anthony Dickman, Secretary to the RBA, as part of the evidentiary history said to support the Applicant's complaints of criminal defamation, criminal trespass on equitable estates, and interference with value and structures relied upon by the Applicant. Those matters are advanced as the Applicant's case and relevant context, not as judicial findings.
33. **Further evidentiary context:** given the Applicant's February 2025 contact with the Chief Executive of Hong Kong SAR and subsequent letter dated 11 May 2025, the Applicant also relies on the timing of the 20 May 2025 Secretary-level response and on the reasonably arguable inference that there may have been significant correspondence between Australian and Hong Kong agencies since commencement and service of HCMP-1855-2022. The Applicant seeks preservation and disclosure of materials so that such matters may be tested lawfully.

4. Supporting evidence

34. This application is supported by the Affidavit of Andrew Morton Garrett sworn on 16th May 2026 and the exhibits referred to therein.
35. The Materials to be produced by Court Orders made to the proposed respondent and the additional proposed interested parties.

5. Proposed Respondent and Interested Parties

36. The proposed Interested Parties are the persons and bodies identified in AMG 9556i dated 10 May 2026 and listed in Schedule 1, together with the additional non-duplicative parties, entities and source lists set out in Schedules 2 and 3. The Applicant contends that those persons and bodies may be relevant by reason of notice, institutional remit, receipt of materials, involvement in the factual matrix, or possession of records. The Applicant accepts that joinder, service and the scope of any directions are matters for the Court and Registry requirements.
37. The Proposed Respondent is the Director-General of Investment Promotion. The Director of Immigration is named as an Interested Party because the Immigration Department's correspondence indicates that InvestHK is responsible for assessment of the Net Asset Requirement before the immigration assessment stage.

6. Time / urgency

38. The application is made promptly and within the time required by Order 53. The matter is urgent because the Applicant's New CIES application has been treated as invalid or ineffective, the Applicant has continued to seek lawful review since the 20 April 2026 invalidation, and the absence of a proper record of the materials before the decision-maker may prejudice meaningful judicial review.
39. The matter is also said to be in the public interest because the impugned conduct is alleged to operate as a practical control on the Applicant's liquidity and capacity to bring capital into the Territory through the Scheme, thereby raising questions going beyond the Applicant's private position.
40. Further public-interest ground: the Applicant says the impugned conduct has the practical effect of controlling the Applicant's liquidity within the Territory by preventing or delaying the lawful admission, validation and deployment of the proposed Net Assets in Hong Kong, such that the legality of the exercise of public power under the Scheme is a matter of public as well as private significance.

7. Additional materials brought to the attention of the decision-maker and interested parties

41. By the correspondence group AMG 9556d, AMG 9556e, AMG 9556f, AMG 9556g and AMG 9556h, the Applicant brought to the attention of DGIP, New CIES and the Director of Immigration additional materials said to bear directly on legality, review, tax residence, profits assessment, dematerialization, and the practical handling of the proposed capital inflow.
42. The Applicant expressly put to the decision-makers that the Order of Nolle Prosequi evidenced by AMG 9193, together with AMG 9191, was capable of being relied upon as a judgment or order of a foreign court for present Hong Kong purposes, and that res judicata, common law, equitable, contractual, promissory and collateral issue estoppel consequences were said to follow.

43. The Applicant also brought to the attention of the decision-makers the HCMP-1855-2022 filing history and supporting documents, including AMG 5857, AMG 6879, AMG 7051, AMG 8879e and AMG 9253, as showing that Hong Kong court materials had already been placed on the record and served by fax and notice to act in person.
44. The Applicant further brought to the attention of the decision-makers the profits-assessment thread with the Inland Revenue Department, including the communication to Ms Yung Wai-Yan seeking validation of TFM 81788 and profits assessment, together with the related invoices AMG 9543f and AMG 9543g, hyperlinks, and the Hang Seng / HKMA banking-dematerialization materials including AMG 9364.
45. The Applicant says that notice to agent is notice to principal and vice versa, such that service or disclosure to ImmD, New CIES, InvestHK, IRD, HKMA, SFC and FSTB, or to their relevant officers or agents, is to be treated as notice across the responsible decision-making structure to the extent permitted by law.

8. Schedule consolidation, reasoning and reference documents

46. **This Second Draft Form 86** consolidates the First Draft Form 86 served on DGIP / New CIES on 12 May 2026. Schedule 1 remains the AMG 9556i interested-party list carried in the served draft. The standalone Schedule 3 prepared from AMG 4 and AMG 9567a is renumbered and consolidated as Schedule 2. The standalone Schedule 4 prepared from AMG 8515c and AMG 8515d is renumbered and consolidated as Schedule 3.
47. **Reasoning for consolidation.** The schedules are included as procedural and evidentiary reconciliation schedules, not as final determinations of joinder, liability, guilt or admissibility. They identify persons, offices, bodies and entities said to be relevant by reason of notice, receipt of materials, institutional remit, possible possession of records, or the potential need for preservation, production, referral or other directions. Duplication is avoided by retaining the original parties and existing Schedule 1 parties, then treating Schedules 2 and 3 as additional non-duplicative source schedules or source-preservation schedules where the original source list should remain visible for the Court and the Proposed Respondent.
48. **Reference documents referred to.** The Applicant relies upon and/or refers to the First Draft Form 86 AMG DGIP for service 12.05.2026; AMG 9556i and AMG 9556a to AMG 9556k; AMG 4 NSD 1848 of 2018 Sealed Tender Bundle 3 Federal Court Indictments; AMG 9567a and its identified attachments; AMG 8515c; AMG 8515d; AMG 6156; AMG 6157; AMG 9567 Suntory Holdings Limited Financial Statements 31 December 2025 Audited; and the affidavit, skeleton submissions and draft minutes of order served or prepared with the related Form 86 materials.
49. For draft consistency, the caption and relief/grounds references should be read as referring to all three schedules. Any entity already captured by Schedule 1 is not repeated as a new party merely because it appears in Schedule 2 or Schedule 3; where the source schedule preserves a repeated source rank or descriptor, that is retained for traceability and not to create duplicate joinder.

9. Preliminary Submission - Referral and Own-Motion Indictable-Offence Relief

50. This Notice of Application incorporates Schedules 1, 2 and 3 as consolidated schedules of proposed interested parties and relevant record-holders. The Applicant maintains the existing judicial-review relief and adds relief directed to the treatment of information before the Proposed Respondent which, on the Applicant's case, reveals indictable offences or suspected indictable offences capable of engaging Hong Kong statutory duties, referral powers, or the Court's own powers.

51. For the purposes of the Hong Kong-law equivalence relied upon in this application, the Applicant refers to the Criminal Procedure Ordinance (Cap. 221), the Organized and Serious Crimes Ordinance (Cap. 455), the United Nations (Anti-Terrorism Measures) Ordinance (Cap. 575), the Anti-Money Laundering and Counter-Terrorist Financing Ordinance (Cap. 615), and any other applicable Hong Kong law. The Applicant will contend that an indictable offence for relevant proceeds and anti-money-laundering purposes includes conduct outside Hong Kong which would constitute an indictable offence if it had occurred in Hong Kong, and that the Court and the Proposed Respondent should not treat the materials as merely administrative where the information before them reveals conduct requiring referral, preservation, investigation or further judicial direction.
52. **Further relief sought:** if, upon the materials before the Proposed Respondent, the Proposed Respondent was or is obliged to refer suspected terrorist financing, money laundering, proceeds-of-crime, fraud, sanctions, false-instrument, public-office, corruption, or related indictable-offence matters to an authorised Hong Kong authority, including the Secretary for Justice, Hong Kong Police Force, Joint Financial Intelligence Unit, Commissioner of Police, Immigration Department, Securities and Futures Commission, Hong Kong Monetary Authority, or another competent authority, an order or declaration to that effect is sought.
53. **Further or alternative relief sought:** if the Court considers that the materials filed, served, exhibited or produced in these proceedings reveal an indictable offence, suspected indictable offence, proceeds of crime, terrorist property, terrorist-financing conduct, money-laundering conduct, or an offence affecting the administration of justice, the Applicant seeks such declaration, referral, preservation, production, case-management direction, or other order as the Court considers lawful and appropriate, including consideration by the Court of its own motion whether any person, office or entity should be referred to a prosecuting or investigative authority.
54. For the avoidance of doubt, the Applicant does not by this Form 86 ask the Court to bypass any mandatory criminal procedure or any requirement of procedural fairness. The relief is framed so that the Court may act within jurisdiction, including by referral, declaration, directions for production and preservation, or such further step as the Court finds available where indictable offences are revealed by the materials.

10. Additional information served on the decision-making structure

55. This Form 86 reconciles some (but not all) of the additional information served or brought to the attention of DGIP / New CIES / InvestHK and the Director of Immigration after the invalidation decision and during the review / referral sequence.
56. The Applicant relies on the correspondence group AMG 9556a to AMG 9556n as further supporting the need for the Proposed Respondent to identify the actual decision-maker, the source of authority, the materials received and considered, and the reasons why the exceptional-case request was not determined substantively before the Applicant was invited to submit a fresh conventional Net Asset Assessment (“NAA”) application.
- **AMG 9556a and AMG 9556b:** Immigration Department / Chief Secretary correspondence and reply sequence, including the request for review / document production and the reply that InvestHK is responsible for Net Asset and Investment Requirements, that Immigration Department is not in a position to assess the matter until the InvestHK certifying proof stage, and that the case had been referred to InvestHK for necessary action.
 - **AMG 9556d and AMG 9556h:** The res judicata / estoppel correspondence and reply sequence, including the contention that AMG 9191 and AMG 9193 may be relied upon as authenticated affidavit and order /

nolle prosequi materials, and the Immigration Department reply of 7 May 2026 that the information provided would also be addressed to Invest Hong Kong for consideration of necessary action.

- **AMG 9556e:** The HCMP-1855-2022 correspondence and filed-document materials, including references to AMG 5857, AMG 6879, AMG 7051, AMG 8879e and AMG 9253, put forward as showing Hong Kong court filing, service, fax confirmation and judicial correspondence history.
- **AMG 9556f and AMG 9556g:** The tax-residence / profits-assessment and banking-dematerialization materials, including the request to Ms Yung Wai-Yan of the Inland Revenue Department concerning TFM 81788, profits assessment, invoices AMG 9543f and AMG 9543g, the Hang Seng / HKMA material AMG 9364, and the New CIES reply dated 8 May 2026 which returned to paragraphs 2.1 and 4.2 of the Scheme Rules and invited a fresh NAA application when the conventional documents were ready.
- **AMG 9556i:** The 10 May 2026 service of the draft Form 86, affidavit, draft minutes of order and skeleton submissions, together with AMG 8782 and AMG 8806 and the expanded list of proposed Interested Parties, to support the contention that the matter should be reconsidered at the level of principle, object and power rather than only by reference to the ordinary CPA pathway.
- **AMG 9556j:** The service of Justice Kirby evidentiary materials, including AMG 8818 and AMG 8819, and the reference to Annexure 2 to AMG 8818 and the Public Interest Disclosure Drive as material said to bear on source-of-power, stored-value, Crown / Commonwealth / Windsor Family Office and Reserve Bank of Australia issues already said to have been drawn to the decision-maker's attention.
- **AMG 9556k:** The service of USA Debt evidentiary materials, including AMG 8738 and AMG 8687, particularly AMG 8738 described as a United States Securities and Exchange Commission demand / crystallization / seizure / retention / appointment document for USD 19,138,034,107,964.00, and as identifying additional persons and entities who may need to provide evidence in the proposed proceedings.

64. Further relief sought: the Applicant seeks a direction that the Proposed Respondent file a schedule and short evidence identifying whether AMG 9556a through AMG 9556n and their attachments, annexures and hyperlinks were received, forwarded, considered and preserved; and, if not, identifying the basis on which they were excluded from the decisional or review record.
65. Further ground: the failure or refusal to engage with, schedule, preserve or identify the treatment of the AMG 9556a to AMG 9556n materials is relied upon as part of the procedural unfairness, inadequate reasons, failure to consider relevant matters, fettering and record-production grounds.

11. Supplemental Amendment - Schedule Consolidation, Asset-Base Rationale, 300% Penalty Case and Hong Kong Penalty Reconciliation

66. The Applicant maintains the Hong Kong and Australian law framework expressed in the documents, including the treatment of Hong Kong indictable-offence, money-laundering, terrorist-financing, proceeds-of-crime, corruption, sanctions, referral and own-motion issues.
- Schedule 1 remains the AMG 9556i interested-party schedule;
 - Schedule 2 consolidates the former AMG 4 / AMG 9567a material; and
 - Schedule 3 consolidates the former AMG 8515c / AMG 8515d material.
67. The purpose of expanding and consolidating the schedules is not merely to lengthen the caption. On the Applicant's case, the schedules demonstrate the reasoning behind the enormous asset base sought by the Applicant to invest, relocate, validate, preserve and administer in Hong Kong. The schedules identify the persons, offices, agencies, professional firms, courts, public bodies, financial institutions, corporate entities and evidentiary materials said to be connected with

the provenance, interference with, seizure, control, valuation, dematerialization, recovery or deployment of the relevant assets, funds, proceeds, instruments and property.

68. The Applicant further contends that the face value of the assets the subject of the alleged indictable offences, money-laundering, terrorism-financing, corruption, proceeds-of-crime or related misconduct must be understood together with the pleaded 300% penalty or remedy calculation. That calculation is advanced by reference to section 20 and/or section 21 of the Charter of the United Nations Act 1945 (AU), annexing Australian Treaty Series No. 1; section 8 of the Registration of Deeds Act 1935 (South Australia); section 64 of the Judiciary Act 1903 (AU); the proper interpretation of the Commonwealth of Australia Constitution Act 1900 (Imperial); the Charter of the Commonwealth 2013 (Imperial); and the acknowledgement by Commonwealth Heads of Government of the enforceability of the Commonwealth Charter as expressed in the 2013, 2018 and 2023 CHOGM communiqués.
69. The Applicant relies on those instruments and communiqués, together with the United Nations Convention Against Corruption 2003 / Australian Treaty Series No. 2, as part of the pleaded public-law and fiduciary framework said to be enforceable against Public Officials. The expression "Public Official" is used in the sense relied upon by the Applicant by reference to UNCAC and the domestic and international materials served or identified in the proceeding.
70. Hong Kong penalty reconciliation. The Applicant draws a distinction between (a) the pleaded Australian / Commonwealth / international-law 300% penalty or remedy as uncontested and admitted, and (b) the criminal penalties, confiscation, restraint, reporting and referral machinery available under Hong Kong law. The Applicant does not presently identify a Hong Kong statutory provision that automatically imposes a 300% penalty of the face value of the relevant assets merely because money-laundering, terrorist-financing, proceeds-of-crime or other indictable-offence allegations are revealed. The Hong Kong-law position is therefore pleaded as a referral, preservation, investigation, restraint, confiscation, disclosure and lawful-determination framework, rather than as an automatic 300% criminal penalty applicable under Hong Kong Law.
71. For Hong Kong purposes, the Applicant relies on the Organized and Serious Crimes Ordinance, Cap. 455, including sections 25 and 25A, as the money-laundering / proceeds-of-indictable-offence framework; the Drug Trafficking (Recovery of Proceeds) Ordinance, Cap. 405; the United Nations (Anti-Terrorism Measures) Ordinance, Cap. 575, including sections 7, 8, 12 and 14, as the terrorist-financing / terrorist-property framework; and the Anti-Money Laundering and Counter-Terrorist Financing Ordinance, Cap. 615, Schedule 1, for regulatory definitions. The Applicant also relies on the Criminal Procedure Ordinance, Cap. 221, section 14A, for the definition and procedural treatment of indictable offences. Cap. 405 is noted only as a parallel Hong Kong proceeds statute. The Applicant's present case is advanced primarily under Cap. 455, Cap. 575 and Cap. 615.
72. On the Applicant's present understanding, Hong Kong law may impose criminal liability on a private person, private entity, public-official person, public body or other person only if the relevant offence provisions, attribution principles, jurisdictional requirements and procedural safeguards are satisfied. A Government or public body employing an accused Public Official is not treated in this draft as automatically liable for the same criminal penalty merely because of employment. Any liability of an employing Government, department, public body or agency would require a separate statutory, public-law, vicarious-liability, agency, misfeasance, restitutionary, indemnity, public-trust or other legal basis to be pleaded, proved and determined according to law.
73. Taxation / public-revenue proceeds point. The Applicant further contends that, if a Government, department, agency, public body or public official collects taxation, fees, penalties, charges or other public revenue from revenues generated by money-laundering, terrorist-financing, corruption, proceeds-of-crime dealing or other indictable-offence conduct, those public receipts may themselves require tracing, scheduling, referral and lawful determination as alleged proceeds, benefits, property or fruits derived from unlawful activity - described by the Applicant as fruit from the poisonous tree. For Hong Kong purposes, this proposition is not pleaded as an automatic rule that all taxation becomes criminal property. It is pleaded as a matter for competent authority consideration where the material reveals a sufficient nexus between the revenue received, the underlying indictable conduct, the person or body dealing with the property, and the knowledge, reasonable grounds to believe, attribution, confiscation, restitutionary or public-law principles applicable under Hong Kong law and any other applicable law.
74. Accordingly, the Applicant asks that the Proposed Respondent be required to schedule, preserve and refer the materials where the information before him gives rise to reasonable grounds to suspect indictable offences, money-laundering,

terrorist financing, corruption, sanctions breaches, proceeds-of-crime dealings, misuse of public office or related matters. The Applicant further asks that the Court preserve its own-motion ability to give referral, preservation, production or other directions if the materials reveal matters requiring competent Hong Kong authority consideration. The 300% calculation remains pleaded as part of the Applicant's Australian / Commonwealth / international-law remedial case and as part of the explanation for the scale of the asset base proposed for Hong Kong, not as a concession that Hong Kong law contains an automatic 300% penalty provision.

75. For the avoidance of doubt, the Applicant advances the 300% penalty case, the schedule expansion and the asset-base reasoning as matters requiring preservation, referral, scheduling, record production and lawful determination. The Applicant does not ask the Court to make any final criminal conviction, final finding of guilt, final confiscation order or final monetary award without jurisdiction, procedural fairness, notice and any criminal or civil procedure required by Hong Kong law or other applicable law.
76. Reference documents and materials. The Applicant relies on or refers to the First Draft Form 86 served on DGIP / New CIES on 12 May 2026, the Second Draft Form 86 with Schedules 1, 2 and 3, AMG 9556a to AMG 9556k and continuing AMG 9556 materials, AMG 4, AMG 9567a, AMG 8515c, AMG 8515d, AMG 6156, AMG 6157, AMG 9567, the pasted statutory text in AMG 567c concerning Australian terrorism-financing and proceeds-of-crime / money-laundering provisions, Australian Treaty Series No. 1, Australian Treaty Series No. 2, the Charter of the Commonwealth 2013, and the CHOGM communiqués identified above.
