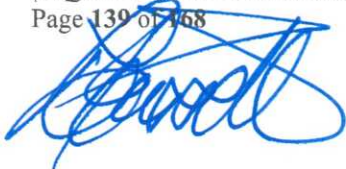

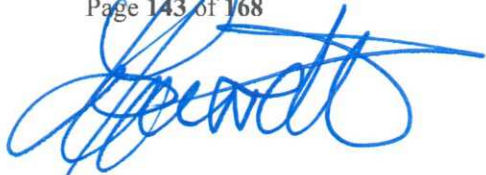

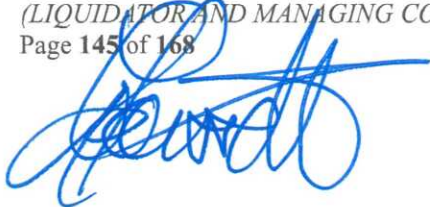

Dear Mr Boylan,

I, (Licensor) act for the King (Licensee) in which regard a copy of your correspondence and this communicate and reference documents will be produced into evidence in HCMP-1855-2022; IN THE MATTER OF THE CROWN (LIQUIDATOR AND MANAGING CONTROLLER APPOINTED) ("the Crown") the originating process of which has been served upon you on more than one occasion since the 11<sup>th</sup> November 2022; Notice to Agent is Notice to Principal and vice versa.

For over 1,000 years the Crown has acted unlawfully and breached the terms and conditions of the respective licenses granted by the Occupant of the Throne of the British Empire to govern the 54 nations comprising the Commonwealth and sought to invalidly fetter the exercise of hereditary discretionary public powers previously the property of the Windsor Family which are now exercised under license from the Andrew Garrett Family. That license is now completely unfettered by the previous thousand years of fettering by invalid enactments passed through various parliaments in a manner that is not in the Public Interest.

Thank you for your correspondence dated 7<sup>th</sup> May 2024 (ANNEXURE), I have considered the relevant section of the act indicated by you and advise it is my determination that *the Constitution Act 1934 SA* is invalid and insofar as the provision you rely upon purports that this Enactment is the relevant source of power for *the Judicial Conduct Commissioner Act 2015 (SA)* then the entirety of that enactment along with the creation of your purported public office is equally invalid.

Of course, the South Australian Parliament has sat continuously since the 1<sup>st</sup> of January 1901 in which regard *the Commonwealth of Australia Constitution Act 1900 (UK)* must be read by its four corners inclusive of the State Constitutions as saved at that time, after which time it was not possible for State Parliaments to enact changes to State Constitutions without a Federal Referendum.

The *Australia Act Request Acts 1985 (AU) (SA), (TAS), (WA), (QLD), (NSW), and (VIC)* and *the Australia Acts 1986 (AU)* and (UK) are invalid for the same reason and any law passed after 1934 and/or 1985 is equally invalid insofar as the provisions do not fulfil the primary purpose of Holding Public Offices as a Public Trust to exercise discretionary public powers exclusively in the public interest.

Until the *Administrative Tribunal Act 1975 (AU)*, the *Federal Court of Australia Act 1976 (AU)*, the *Administrative Decisions Judicial Review Act 1977 (AU)* and the *Federal Circuit Court Act 1999 (AU)* the courts of the States and Territories were the exclusive original jurisdiction for all matters arising in proceedings whether State or Federal in Character resulting in Corruption of the Crown at all power levels driven by the Law Societies of Australia, the National Law Council, CPA Australia Limited, Australian Banking Association.

Similarly until the *Insolvency Act 1986 (UK)*, the *ASIC Act 1990 (AU)*, the *Goods and Services Tax (a New Tax System) Act 1999 (AU)*, the *Australian Business Number (A New Tax System) Act 1999 (AU)*, the *Corporations Act 2001 (AU)*, the *AML/CTF Act 2006 (AU)* the *Cross Border Insolvency Act 2008 (AU)*, the *Personal Property Security Act 2009 (AU)*, the *Judiciary Misconduct and Incapacity (Parliamentary Committee) Act 2012 (AU)*, the *Global Magnitsky Act 2012 (USA)*, the *Charter of the Commonwealth 2013 (Regina)*, the *Public Interest Disclosure Act 2013 (AU)* the *Public Governance Performance and Accountability Act 2013 (AU)* the *Common Law Jurisdiction Model Law on Anti Money Laundering and Counter Terrorism Financing 2016 (Commonwealth Secretariat)*, the *Sanctions and Anti Money Laundering Act 2018 (UK)* the *Royal Commission into the Financial Services Sector 2019*, there was no mechanism to control the regulators and the fake regulation observed in that Royal Commission.

You have again evidenced that the purpose of Federation continues to be eroded and the where there is a discrepancy between a state law and a commonwealth law that discrepancy is ignored and that in as far as the States and Territories are concerned they act Autonomously and Invalidly at the expense of the Public Good.

By failing to exercise discretionary public powers conferred under enactments in the public interest I find as a fact that you have breached s20 and/or s21 of the *Charter of the United Nations Act 1945 (AU)* as a major Indictable Offence for enforcement in the Hong Kong Proceedings.

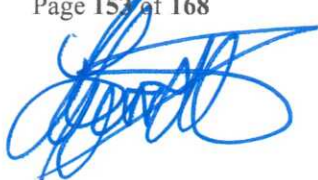

### Why your objection does not change our view

On 19 June 2026, we wrote to you and explained that because OenoViva had not received a Financial Service from HSBC, we were unable to proceed with your complaint in accordance with AFCA Rule B.2.1(a).

Unfortunately, your response to our decision has not changed our view.

### HSBC has not provided OenoViva with a financial service

#### Background

In accordance with the 1 July 2024 version of the AFCA Rules, Rule A.4.3(a) states that:

*There are some additional requirements that must be met in order for AFCA to be able to consider a complaint.*

*In summary:*

*a) The complaint must arise from a customer relationship or other circumstance that brings the complaint within AFCA's jurisdiction.*

...

**Section B sets out these requirements.**

Rule B.2.1(a) goes onto state that:

*A complaint (other than a Superannuation Complaint) must arise from or relate to:*

*a) the provision of a Financial Service by the Financial Firm to the Complainant;*

#### How this applies to your complaint

In this complaint, you mention that a transfer was made from an HSBC account in Australia to Custodian Bank in Brazil, totalling USD8,500, as well as a deposit of AUD255,963.84 into that account. However, HSBC confirmed this account did not belong to you, and you were not a HSBC customer at the time of the events mentioned in your complaint took place.

Rule B.2.1(a) requires that a complaint must arise from or relate to a Financial Service provided by the Financial Firm to the Complainant. This means that because your complaint does not relate conduct regarding an account you received from HSBC, we are unable to consider your complaint any further.

HSBC's response to your complaint dated 26 February 2026 indicates that you did open an account with them in your personal name. However, this occurred after the alleged conduct you mention in your complaint, and you have not raised any concerns in relation to this account. Therefore, this complaint does not relate to that particular account, and its existence does not change the outcome of our assessment.

Instead, it appears you have focused on an account belonging to a third-party and you have not supplied any documentation that shows that account either belongs to you (contrary to HSBC's assertions) or that you have the authority on behalf of the account holder to make that complaint.

As a result, without anything to establish that Rule B.2.1(a) has been satisfied in this complaint, we are unable to proceed with it any further.

The other matters raised in your objection do not appear to change the nature of your relationship with HSBC generally, so they have not been persuasive in changing AFCA's jurisdictional assessment.

## Conclusion

From the information provided, we ceased consideration of your complaint because it does not relate to a Financial Service provided to you by HSBC for the purposes of Rule B.2.1(a). Your response to our decision dated 19 June 2026.

For the reasons outlined above, I am satisfied that your objection to our initial decision lacks substance and we will not consider the complaint further.

We have now closed the file. This assessment is the final stage of AFCA's jurisdictional review process and there are no further internal avenues of appeal. As such, your options are now external to AFCA.

I understand this outcome is disappointing and not what you were hoping for in the circumstances. However, we lack the power to assist you on this occasion, so we are unable to proceed with the complaint any further.

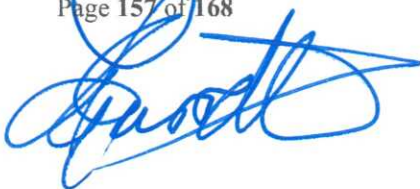

**PREAMBLE – INSOLVENCY: ABDICATION OF THE RIGHTS AND DUTIES OF STATES**

I give this Notice because the governments and institutions identified in the instruments and exhibits have abdicated the rights and duties of States that they publicly profess to uphold. Those rights and duties include sovereign equality, good-faith performance of public obligations, peaceful and lawful administration, non-intervention, protection of the population, observance of international law, respect for human rights, and the exercise of discretionary public power exclusively for the public interest.

During fifty-three years of trading activity commencing in 1973, I have tested the operation of those stated principles against the conduct of governments, courts, tribunals, regulators, financial institutions and professional record-keepers. The matters giving rise to this Notice have been tested through more than seven hundred proceedings in courts and tribunals in the United Kingdom, Australia and the United States of America, together with the related administrative, regulatory and enforcement processes recorded in the exhibits.

That record establishes that the relevant governments and institutions have repeatedly represented that their powers are exercised to uphold the rule of law, protect the public, protect revenue, prevent financial crime, provide an effective remedy and ensure equal administration of justice, while acting in a manner that produces the reverse result. I have determined that the discrepancy between the stated purpose and the conduct undertaken is not accidental administrative failure, but a continuing abdication and reversal of the rights and duties of States.

I determine that, where Government has not fulfilled its stated common-law and statutory purpose including but not limited to treaty obligations to provide for an effective remedy, the only conclusion available to an independent and fair-minded observer is that Government is saying one thing while doing the reverse. The conduct thereby constitutes fraudulent trading and acts of insolvency under the applicable corporations law and, in the circumstances established by the documentary record, constitutes terrorism financing and money laundering undertaken under the cloak of the misrepresentation that the conduct is necessary to protect the revenue.

I further determine that the public powers, institutions and financial systems concerned have been used to receive, retain, conceal, transfer, administer or protect property and value while obstructing independent investigation, production of records, accounting, adjudication and enforcement. The failure to apply the law equally to government, systemically important institutions and their officers has created practical impunity while preserving the appearance of formal legality.

Government is not entitled to obtain, retain or rely upon revenue, property, advantage or legal consequence produced by its own unlawful conduct, improper purpose, material misrepresentation, obstruction or abuse of public power. It is not entitled to the fruit of the poisonous tree and cannot manufacture the circumstances upon which it then relies to enrich itself, defeat a liability, deny an effective remedy or prevent enforcement.

I make those findings and determinations in the exercise of the hereditary discretionary public powers conferred upon me by the enactments, appointments, licences, security instruments, judgments, defaults, removals, seizures and retentions identified in this Notice and in the wider documentary record. Those powers are exercised by me independently of the institutions whose conduct is in issue and continue through my lawful heirs, successors and assigns according to the terms of the instruments relied upon.

The prolonged abdication of the rights and duties of States, the exhaustion of conventional remedies over the course of the proceedings and experience described above, and the continuing necessity to preserve, administer and enforce the affected rights, powers, property, obligations and public interests have led directly to the giving of this Notice of Succession of States.

**A. ADDRESSEES, FILING AND PURPOSE**

5. The documents are relied upon as a single chain of decision, notice, service, implementation, accounting, enforcement, certification and deployment, rather than as disconnected categories of evidence.

#### **B. PERSON GIVING NOTICE, CAPACITY AND CONTINUITY**

6. I, Andrew Morton Garrett, give this Notice in the offices, appointments, capacities and licensing functions recorded in the instruments and proceedings identified in the Schedule of Exhibits.
7. I give notice that the rights, powers, licences, offices, interests, duties and responsibilities relied upon continue according to their terms through me and my lawful heirs, successors and assigns.
8. I give notice that the global seat of the Crown authority administered under the instruments relied upon is ambulatory and is situated wherever I, or the lawful heir, successor or assign through whom that authority is then administered, am personally present and exercising the relevant office, licensing, controlling and enforcement functions.
9. Hong Kong is not the original source of that authority. It is the jurisdiction in which I propose to establish my personal domicile and the principal territorial base for the Family Office, primary tax administration, treasury, custody, professional verification, judicial enforcement, licensing administration, commercial implementation and public-benefit programme.

#### **C. BASIS FOR PROPOSED DOMICILE AND INDEPENDENT REGULATION**

10. I propose to establish my domicile in Hong Kong because the evidentiary record upon which I rely describes continuing human-rights violations, denial of an effective remedy, institutional conflicts of interest, interference with judicial and administrative processes including my attempts to relocate to Hong Kong commencing 18<sup>th</sup> May 2016, and failures of independent supervision within Australian and associated Crown institutions.
11. My position is that regulation by institutions whose conduct, officers, beneficiaries or delegated powers are themselves in issue is self-regulation and mis-regulation rather than independent regulation.
12. I rely upon my position as creditor, liquidator, managing controller, source, licensor and controlling authority of the relevant Crown powers as establishing an independent regulatory and enforcement function capable of investigating misuse, preserving and compelling records, restraining unauthorised exercises of power, administering the appointments and providing an effective remedy.
13. My proposed Hong Kong domicile does not displace the ambulatory global seat of authority. It provides the principal legal, tax, treasury, custody, family-office and operating base from which I, and in due course my heirs, successors and assigns, will administer the continuing structure.

#### **D. PRIOR COLORADO PROCEEDINGS AND DEFAULT**

14. The relevant proceedings in the United States District Court for the District of Colorado include Case Nos.
  - 1:22-cv-00173-DDD-STV: *Garrett [sic.] et al v Garrett [sic.] et al*

- 1:22-cv-00206-DDD-STV; *Garrett [sic.] et al v Bankrupt Estate of Jersey Green AND Esch et al v CarbonHelix*
- 1:22-cv-00243-GPG / DDD-STV; *Garrett v Secretary General and Secretariat of the United Nations & Anor*, and
- 1:22-cv-00254-DDD-STV; *Garrett et al v Suntory Holdings Limited (Managing Controller Appointed)*.

15. Case No. 1:22-cv-00243 named the Secretary-General and Secretariat of the United Nations and placed the United Nations on notice of the matters pleaded and relief sought.
16. Australia, the United Kingdom and relevant Commonwealth institutions, the United States of America and the United Nations were served or otherwise placed on notice in the manner recorded in the originating process, notices, certificates, correspondence and related exhibits.
17. No appearance or substantive contradicting evidence is recorded as having been filed by those entities in response to the matters relied upon in the removal and enforcement instruments.
18. The resulting defaults, non-contestation and absence of a contradictor are relied upon as producing the consequences recorded in the exhibits, including crystallisation, seizure, retention, appointment, removal and enforcement.

#### E. SEVENTH AND EIGHTH ENACTMENTS

19. On 16 April 2022, the Seventh Enactment took effect according to its terms as the instrument recording the seizure and retention of United Nations powers and related collateral.
20. The Seventh Enactment was placed in the Colorado federal court record as part of Case No. 1:22-cv-00254-DDD-STV, Document 13-9, filed 18 April 2022.
21. On 11 May 2022, the Eighth Enactment, SN 1.00310.22, recorded the crystallisation, seizure and retention of the powers, property, collateral and governmental interests of the United States of America identified in that instrument, together with the appointment and enforcement powers stated in it.
22. The Seventh and Eighth Enactments form part of the same continuous enforcement sequence as the Colorado proceedings, the Notices of Removal and the later continuation of those matters in HCMP 1855/2022.
23. **The seizures and retentions recorded in those instruments have not been contested, discharged, revoked, restrained or set aside by any person or by any competent final order known to me.**

#### F. REMOVAL FOR ENFORCEMENT

24. The Notice of Removal dated 14 May 2022, Third Notice of Removal dated 17 May 2022, Fifth Notice of Removal dated 25 May 2022 and Amended Fifth Notice of Removal dated 28 May 2022 form a continuous record of removal, default, crystallisation, seizure, retention and enforcement.
25. As a consequence of the defaults of Australia, the United Kingdom and relevant Commonwealth institutions, the United States of America and the United Nations, the proceedings were removed from the Colorado forum for enforcement.
26. The removed proceedings and their subject matter were brought before the Court of First Instance by the sealed ex parte originating summons filed on 11 November 2022 as HCMP 1855/2022, exhibited as AMG 5857.
27. AMG 5858 records transmission, circulation and service of the filed Hong Kong process, including notice to affected governments, institutions, officers and persons and invitations to persons claiming standing to intervene or make submissions.
28. HCMP 1855/2022 is relied upon as the receiving proceeding for recognition, possession, control, administration and enforcement of the judgments, findings, orders, appointments, seizures, retentions, security interests, collateral, estates, entities and consequential rights recorded in the exhibits.
29. The purpose of this Notice is not to invite a rehearing of the merits but to give formal notice of the completed procedural history and seek recognition, case-management directions, circulation and implementation of its consequences.

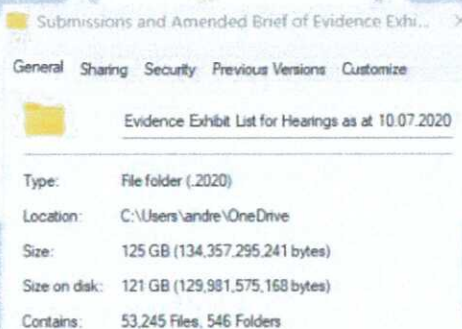

**G. RES JUDICATA, ISSUE ESTOPPEL AND ESTOPPEL BY RECORD**

30. The matters were placed before affected persons and institutions with an opportunity to appear, answer, dispute, seek relief or invoke any available jurisdictional or immunity objection.
31. No substantive contest is recorded as having been made by Australia, the United Kingdom and relevant Commonwealth institutions, the United States of America or the United Nations in respect of the matters relied upon in the instruments listed in the Schedule of Exhibits.
32. **I rely upon res judicata, cause-of-action estoppel, issue estoppel, estoppel by record, estoppel by convention, waiver, acquiescence and abuse-of-process restraint as precluding collateral re-litigation of matters concluded or left uncontested in the proceedings.**
33. The absence of any competent final order expressly setting aside or discharging the relevant instruments is relied upon as confirming that the acts recorded in them remain operative according to their terms.

**H. NOTICE OF SUCCESSION AND INTERNATIONAL COMMUNICATION**

34. Notice is given, subject to the directions and determination of the Honourable High Court of Hong Kong and without prejudice to any diplomatic or depositary formality, of the succession, continuity and transfer of international responsibility recorded in the primary instruments.
35. The international-law materials relied upon include the Vienna Convention on the Law of Treaties 1969, the Vienna Convention on Succession of States in Respect of Treaties 1978 and the treaty schedule and supporting materials identified in AMG 9684 and as otherwise disclosed in the Public Interest Disclosure Drive at the address in the cloud: <https://1drv.ms/f/c/13ebd865c7415cd41gDUXEHHzdjrIATrzYAAAAAAXmTvYhfqIST2s4c0k-luMI?e=JFrAqi>



36. The Secretary-General is requested to receive the Notice, allocate an official reference, refer it to the Treaty Section and Office of Legal Affairs, preserve it as an official communication and identify any further depositary or authentication requirements for recording the succession and treaty consequences notified.
37. The President of the Security Council is requested to bring this Notice and its exhibits to the attention of Council members and arrange circulation in accordance with applicable Security Council procedure.
38. The Secretary-General and President of the Security Council are requested to acknowledge the prior proceedings, defaults, completed seizures and retentions, removal and continuation for enforcement in HCMP 1855/2022 and as a matter arising within HCAL-1179-2026 related to production of records.

**I. HONG KONG RELOCATION AND REDOMICILIATION**

39. The Hong Kong relocation is stated not to have originated with the July 2026 Masterplan. The materials record a relocation resolution made in 2016 and a progressive programme of transferring primary tax jurisdiction, management, trustee control, financial administration, records, instruments, personnel and value to Hong Kong.

- 40. AMG 8571, dated 2 February 2025, records the formal proposal to the Chief Executive for relocation of global financial operations and primary tax jurisdiction, transfer of accounts and instruments to Hong Kong administration, relocation of personnel and establishment of the Hong Kong operating base.
- 41. AMG 8859, dated 11 May 2025, records attempted implementation of that programme, including instructions for transfer of tax files of related entities, proposed currency conversion and transfer of identified value, use of the Hong Kong trustee structure and the proposed role of the Hong Kong Monetary Authority.
- 42. AMG 9338, dated 2 January 2026, is the consolidated executive and regulatory submission seeking safe-harbour recognition, confirmation of primary tax jurisdiction under TFM 81788, regulatory onboarding, cross-agency coordination and safeguarding of value redomiciled from Australia.
- 43. The entity and legacy-identifier schedules are relied upon as mapping and consolidating the related entities, tax files and residual value beneath the Hong Kong administration identified by TFM 81788.

#### J. IDENTIFIED VALUE AND NEW CIES CERTIFICATION

- 44. The value proposed for Hong Kong administration is identified in the materials as accumulated, traced and administered balance-sheet, trust, corporate, intellectual-property, contractual, commercial, receivable, recovery, custody, securities, tax, land-rights, licensing, brand and related-entity value recorded in AMG 9477, AMG 9510, AMG 9673 and supporting exhibits.
- 45. AMG 9477 Tabs 1-18 form the organised New CIES, source-of-value, custody, accounting, tax, trust, instrument, court and transaction dossier presented for Hong Kong assessment and professional certification.
- 46. AMG 9510 consolidates the group structure, entities, interests and asset position for the Hong Kong presentation.
- 47. The value further includes the entities, appointments, rights, interests and collateral the subject of HCMP 1855/2022 and HCAL 1179/2026 and the future operating platforms identified in the Masterplan.
- 48. My New CIES application bears Transaction Reference **IHK0010JMCKT9T09** and required a fulfilment document issued by a Hong Kong CPA (Practising), supported by records necessary to demonstrate my net asset position.
- 49. I was unable to obtain a suitably qualified Hong Kong-domiciled accountant willing and able to accept the engagement and certify the value without production and reconciliation of records held by professional record-keepers, courts, regulators, counterparties and governmental bodies and will request the court to order Price Waterhouse Coopers to undertake CPA compliance and/or dispense with necessity under the New CIES Rules.

#### K. HCAL 1179/2026 AND COORDINATED CASE MANAGEMENT

- 50. HCAL 1179/2026 was commenced in the Constitutional and Administrative Law List in support of, and as a proceeding related to, HCMP 1855/2022.
- 51. HCAL 1179/2026 addresses the administrative pathway, decisional record, production of primary records and judicial directions required to permit certification and regulated treatment in Hong Kong of the already identified value.
- 52. HCMP 1855/2022 concerns the asserted historical source, ownership, control, appointments, seizures, retentions, records, treaty consequences and administration of the relevant value; HCAL 1179/2026 concerns the practical Hong Kong pathway by which that value may be independently examined, certified, admitted to New CIES, relocated, invested and administered.
- 53. The two proceedings arise from the same factual, evidentiary and value-relocation matrix and are proposed to be heard together or managed under coordinated directions.
- 54. On 18 July 2026, the proposed HCMP notices and related materials were forwarded to the Registrar and the parties in HCAL 1179/2026 for administrative commentary before lodgment with the Registry.

**L. FAMILY OFFICE, OENOVIVA AND THE PEARL GLOBAL SHOWCASE**

55. AMG 9673 is the consolidated government-facing explanation of the architecture and connects the relocation resolution, trust and Family Office structure, source and continuity of value, Hong Kong tax administration, New CIES dossier, HCMP enforcement, HCAL certification, OenoViva licensing and public-benefit deployment.
56. The Andrew Garrett Family Office is the governance, ownership and intergenerational continuity architecture. OenoViva Capital Resources is the principal capital, accounting and treasury-administration point. OenoViva is the government and trading-partner-facing business and licensing system. OenoViva Artisans and OenoViva Hand Crafting are the consumer-facing and craft-production systems.
57. The Pearl is not identified as the source or ambulatory seat of Crown authority. It is the proposed Hong Kong flagship showcase and physical proof-of-system for the value, intellectual property, business systems, public-benefit architecture and operating entities administered through the Family Office.
58. The Pearl proposal suite comprises the Island Side vertical harbour city and headquarters functions; Urban Winery and Hospitality Space; Global Glasshouses; Aquarium and Submerged Marine Harbour Experience; Kowloon Side repository, data and vault infrastructure; Dragonhead production and visitor facilities; The Vault; and the Pearl Skyway.
59. The Pearl materials are relied upon as the physical deployment plan for the relocated value: headquarters, financial administration, intellectual-property deployment, production, hospitality, tourism, conservation, education, data, custody, infrastructure and public benefit.

**M. PRIOR CIRCULATION FOR ADMINISTRATIVE COMMENTARY**

60. Before formal lodgment, I circulated AMG 9633k, AMG 9633l, AMG 9679, AMG 9680, AMG 9681, AMG 9684, this Notice, the proposed exhibit schedule and supporting materials to the Registrar and the parties and proposed interested parties in HCAL 1179/2026.
61. The circulation was undertaken to identify any administrative issue concerning form, filing, allocation, status of the HCMP Court file, coordinated management, service, treatment of international organisations, exhibit indexing and conformity with the sealed record.
62. The request for administrative commentary did not invite determination of the substantive merits of the succession, removal, seizure, treaty or enforcement issues.
63. I reserve the right to amend the documents in response to administrative commentary without abandoning or prejudicing any substantive position recorded in the notices and supporting materials.

**N. RELIEF AND DIRECTIONS REQUESTED**

- a. Receive and place this Notice and its schedules upon the record of HCMP 1855/2022.
- b. Direct the manner of filing, service and international communication of the Notice.
- c. Restore, reopen and list HCMP 1855/2022 and give directions for coordinated case management with HCAL 1179/2026.
- d. Preserve and require production of the Court, governmental, regulatory, professional, tax, banking, accounting, trust, corporate and transaction records necessary to administer and certify the identified value.
- e. Give directions concerning the treaty schedule, depositary communications, party constitution, representative treatment, service and international notice.
- f. Give such recognition, enforcement, possession, control, administration, accounting, custody, valuation and consequential orders as the Court considers lawful.
- g. Record the relationship between the succession notice, the Hong Kong relocation programme, New CIES certification and The Pearl Global Showcase.
- h. Direct that communications from the United Nations, Member States and affected institutions identify HCMP 1855/2022 and be preserved on the Court record.
- i. Control of the Reserve Bank of Australia and the Bank of England Servers.
